### **New UCLL and Exchange Space Colocation Relinquishment Rate Card – Trial Agreement**

To make it simpler for you to continue to relinquish your UCLL and Exchange Space Colocation, we are replacing our original Relinquishment Rate Card Trial with a new trial (**New RQ Trial**).

The New RQ Trial continues to make rate card pricing available for UCLL Colocation or Exchange Space Colocation relinquishment activities, but now does so at reduced prices to reflect changes to the way we will manage these activities.

The New RQ Trial is being used to assess a new internal methodology for relinquishments which, if successful, Chorus expects to make available on an ongoing basis.

This Appendix to this letter sets out the terms on which Chorus New Zealand Limited (**Chorus**) will offer the New RQ Trial.

You may participate in the New RQ Trial by signing this letter (**Trial Agreement**).

The terms of the New RQ Trial will prevail over the terms of the UCLL Colocation STD or Exchange Space Services Agreements (as applicable) to the extent of any inconsistency between them.

## APPENDIX

### Terms of the Trial

#### ***Terms of the Chorus New UCLL and Exchange Space Colocation Relinquishment Rate Card Trial***

##### **Term**

1. The New RQ Trial is available for you to accept from **15 October 2019 (Commencement Date)**, and has effect from the date you sign this Trial Agreement.
2. The New RQ Trial will terminate on;
  - (a) **15 April 2020**; or
  - (b) Chorus giving you 30 days' notice, **(Termination Date)**.
3. Chorus may extend the time period or extend the scope of the New RQ Trial by giving 30 days' notice in a Customer Update.

##### **Qualifying Orders**

4. The New RQ Trial is limited to Relinquishment Order requests for UCLL Colocation and Exchange Space Colocation received from the date you sign this Trial Agreement.

##### **Ordering**

5. The Services provided in the New RQ Trial may be ordered using the current ordering process as set out in UCLL Colocation Operations Manual and the Exchange Space Colocation Operations Manual.
6. Relinquishment Orders under the New RQ Trial will be carried out in accordance with the current BAU process as set out in the in UCLL Colocation Operations Manual and the Exchange Space Operations Manual, excepting that fixed price charges will be applied as per pricing in the table at Clause 7 below.

##### **Charges**

7. The Charges set out in the table below will apply. All other Charges set out in the Price List will apply. Any Price on Application items will continue to require a quote.

**Conditions**

9. If you signed the original UCLL and Exchange Space Colocation Relinquishment Rate Card Trial Agreement, by accepting this Trial Agreement you agree that:
  - (a) (subject to 9(b) below), the terms of this New RQ Trial replace the terms of the UCLL and Exchange Space Colocation Relinquishment Rate Card Trial Agreement and the UCLL and Exchange Space Colocation Relinquishment Rate Card Trial Agreement is terminated; and
  - (b) any in-flight relinquishment orders under the original UCLL and Exchange Space Colocation Relinquishment Rate Card Trial Agreement will continue to be processed and charged according to that agreement.
