



**CSA Service Appendix - Schedule 2**  
Service Description for the Third Party Access and  
Distribution Service

## **1 Interpretation**

- 1.1 References to clauses or sections are references to clauses or sections in this Service Description unless expressly provided otherwise.
- 1.2 The definitions set out in the General Terms, Special Terms and Operations Manual apply to the extent that they are not expressly modified by or inconsistent with the context of this Service Description.
- 1.3 References to the Operations Manual, Price List and Special Terms are references to those documents under the same Service Appendix as this Service Description. References to the Service Appendix are references to the Service Appendix for the Third Party Access and Distribution Service.

## **2 Third Party Access and Distribution Service**

- 2.1 The Third Party Access and Distribution Service:
  - 2.1.1 Allows a Service Provider's External Tie Cable to enter a Chorus Site from the Entry Point and terminate on the MOFDF on the L Side;
  - 2.1.2 Uses Fibre Drawer Connectivity to connect the External Tie Cable from the Fibre Drawer on the L Side to the Fibre Drawer on the Q Side using on the same physical MOFDF infrastructure (i.e. in the same physical row)
- 2.2 The Third Party Access and Distribution Service specifically excludes:
  - 2.2.1 Tie Cables;
  - 2.2.2 access to any Chorus Site, including the MOFDF, unless expressly authorised by Chorus;
  - 2.2.3 installing equipment on the MOFDF to undertake aggregation functions;
  - 2.2.4 use of any Distribution Frame other than the MOFDF to terminate any External Tie Cable;
  - 2.2.5 connecting the External Tie Cable to any services, whether provided by Chorus, the Service Provider and any Other Service Provider, that do not expressly permit any such connection under the relevant terms and conditions of such service;
  - 2.2.6 any equipment (other than the External Tie Cable and Fibre Drawer Connectivity) of the Service Provider or any third party being installed on the MOFDF, including any active electronic equipment;
  - 2.2.7 the ability to connect two Third Party Access and Distribution Services to each other on the L side of the MOFDF.
  - 2.2.8 the ability to connect a Third Party Access and Distribution Service to a service on the L side of the MOFDF, except with Chorus' prior written consent.

## **3 Operational Prerequisites to the Third Party Access and Distribution Service**

- 3.1 Prior to the installation or reconfiguration of any Third Party Access and Distribution Service, the Service Provider shall:
  - 3.1.1 Ensure that it will comply with any specifications set out in the Operations Manual or any quote for the installation or reconfiguration of any Third Party Access and Distribution Service.

- 3.1.2 Provide Chorus with evidence (reasonably satisfactory to Chorus) of permission which allows the Service Provider to connect to any Other Service Provider's equipment. In the case of the Other Service Provider ordering the connection to the Service Provider's Third Party Access and Distribution Service, the Service Provider will provide consent to the Other Service Provider to connect such service to the Third Party Access and Distribution Service.
  - 3.1.3 Ensure that, where the Third Party Access and Distribution Service will be used in conjunction with any other service, whether provided by Chorus, the Service Provider or any Other Service Provider, such use complies with the terms and conditions of such other service. For the avoidance of doubt, the Service Provider shall be responsible for ensuring the continued compliance of such use after any installation of reconfiguration.
- 3.2 All External Tie Cables including large pair count cable must be approved by Chorus (in its absolute discretion) to ensure that they are able to be easily installed within Chorus' existing cable tray structure taking into consideration bend radius.

## **4 Transaction Charges**

### ***Installation/Reconfiguration of the Third Party Access and Distribution Service***

- 4.1 Chorus will undertake the activities in relation to the installation or reconfiguration of the Third Party Access and Distribution Service as set out in and once a quote has been accepted. Such activities may include:
- 4.1.1 Identifying the install route of any External Tie Cables on the Chorus Site;
  - 4.1.2 If requested by the Service Provider, provide the External Tie Cable;
  - 4.1.3 Bringing the External Tie Cable from the Chorus Entry Point and connecting the External Tie Cable to the L Side;
  - 4.1.4 Allocating the position of the External Tie Cable on the Fibre Drawer on the MOFDF; and
  - 4.1.5 Providing connectivity between the Fibre Drawer on the L Side and the Fibre Drawer on the Q side.

### ***Relinquishment of the Third Party Access and Distribution Service***

- 4.2 Chorus will undertake the following activities in relation to the relinquishment of the Third Party Access and Distribution Service once a quote has been accepted:
- 4.2.1 Removal of the External Tie Cables and any associated Fibre Drawers Connectivity on the Chorus Site.

### ***Quotes***

- 4.2.2 Where Chorus provides any quotes for any services under this Third Party Access and Distribution Service, it shall use reasonable endeavours to achieve any timeframes or dates provided in the quote. However, Chorus shall have no liability in the event that any such timeframes or dates are not achieved.

### ***Transaction Services Generally***

- 4.3 Chorus is solely responsible for performing all work (including identification of all routes and/or installing all Cables) within the Chorus Site, Chorus ducts, the exchange manhole, the Entry Point and between the exchange manhole and the Entry Point (where those two points are different).

## **5 Recurring Charges**

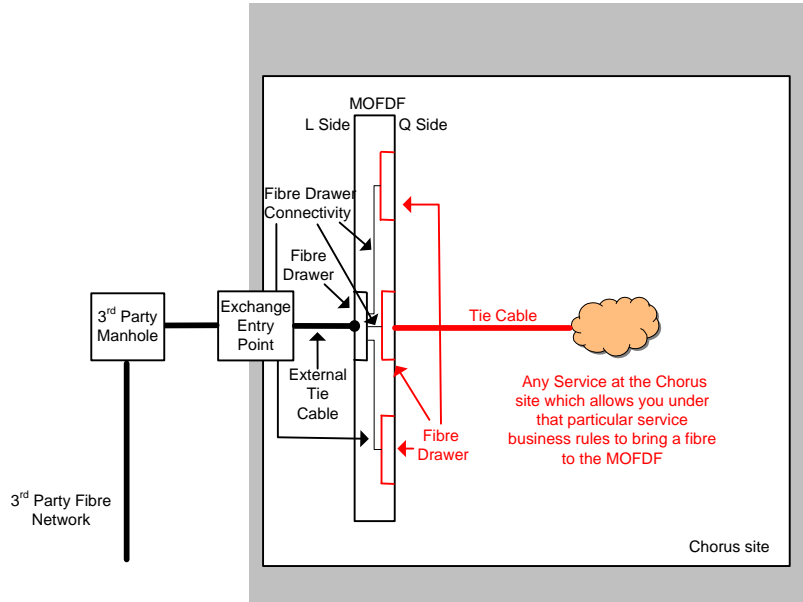
- 5.1 Following the installation or reconfiguration of the Third Party Access and Distribution Service:

- 5.1.1 The External Tie Cable will be connected to the L Side and the "External Tie Cable" Charges for space rental as outlined in the Price List will apply. Chorus' base unit is D24 with a 24 Fibre Drawer. Any External Tie Cables greater than D24 will be charged in multiples as if each D24 was a separate External Tie Cable, with any fibres less than 24 being charged at the full D24 rate;
- 5.1.2 Any Fibre Drawer Connectivity between the L Side and the Q Side of the MOFDF will be charged to the Service Provider in accordance with the "Fibre Drawer Connectivity" Charges in the Price List. For the avoidance of doubt, to the extent that an instance of the Fibre Drawer Connectivity is supplied and charged as a "MOFDF Connection Point" under the Exchange Space Service whether by the Service Provider or an Other Service Provider, there will be no charge for such instance of the Fibre Drawer Connectivity under the Third Party Access and Distribution Service.

## **6 Faults**

- 6.1 Chorus will investigate and fix faults in accordance with clauses 25 to 28 of the General Terms.
- 6.2 If following the receipt of any Reported Fault, Chorus does not identify a fault that Chorus is responsible for under clauses 25.1 of the General Terms, the 'No fault found' Charge in the Price List will apply.
- 6.3 If requested by the Service Provider, Chorus may agree to fix any Reported Fault and the "Fixed faults at Service Provider's request" Charge in the Price List will apply.
